Purpose

This paper provides you with the letters needed to complete the appointments to nine institutes
of technology and polytechnic (ITP) councils. It also provides you with letters to notify the

 - Appoint Mr Ben VANDERKOLK as Chair of the Universal College of Learning (UCOL) council from 1 May 2018 to 30 April 2021, the end of his term as a member
 - Reappoint Ms Leanne SOUTHEY as a member and appoint her Deputy Chair of the UCOL council for a term of three years from 1 May 2018 to 30 April 2021.
 - Reappoint Ms Pamela JEFFERIES as a member of the UCOL council for one year from 1 May 2018 to 30 April 2019.
 - Appoint Ms Annette MAIN ONZM as a member of the UCOL council for two years from 1 May 2018 to 30 April 2020
 - Appoint Mr Daniel FLEMING as a member of the Western Institute of Technology at Taranaki council for two years from 1 May 2018 to 30 April 2020.
