Purpose

- 1. The purpose of this report is to provide you with the Tertiary Education Commission's (TEC) Quarter Three Performance Report for the 2018/19 year.
- 2. We recommend that you release this Tertiary Education Report in full, with officials' contact details withheld, once it has been considered by you.

Background

- 3. We report quarterly to you on our performance. This report covers the period 1 January 2019 to 31 March 2019.
- 4. The Ministry of Education, as our lead monitor, will provide you with a separate report on our performance.

The Quarter Three Performance Report

- 5. The Quarter Three Performance Report covers our progress against our *Statement of Intent* 2018/19 2021/22 (SOI) and the *Statement of Performance Expectations* 2018/19 (SPE).
- 6. It shows that the TEC is performing well, and provides an update on our:
 - progress made against our two functions (Champion and Invest) and our three enablers (Partnership, Knowledge and People)
 - financial performance information
 - non-financial performance information.

Our financial performance

- 7. Our year to date operating deficit of \$1.6 million is \$3.7 million less than our budgeted deficit.
- 8. By year end we are forecasting a \$3.1 million deficit as we increase expenditure on key projects including the Careers System Strategy (CSS). We also forecast we will have fully spent the \$5 million of Crown funding for the Reform of Vocational Education (RoVE), however this project is evolving quickly, and this may remain a key variance at year end.
- 9. Overall grant spend is forecast to be \$3.057 billion which is slightly higher than last year's grant spend of \$2.995 billion. The increased spend is mainly due to a full year of Fees Free costs.
 - We have completed the first calendar year of the Fees Free policy which had a net total spend of \$237 million, and now have more certainty on student uptake and final costs.
 - We are able to reduce 2018/19 baselines to recognise the accounting impact of the expiry of the Canterbury recovery exemption.

10. All spending is forecast to be within appropriated limits in 2018/19.

Our non-financial performance

- 11. We report progress against measures where we have relevant new data. This report contains progress information for 12 of our SOI and SPE measures. As at 31 March 2019, we were on track to meet nine of these 12 measures.
- 12. One measure reports baseline year data and the two measures not on track relate to unplanned turnover and learners at ICT graduate schools.
 - Unplanned turnover is expected to achieve the target by the end of the year.
 - The number of learners at ICT graduate schools is not expected to achieve the target by the end of the year. However, all three schools have grown enrolments year on year.
