Purpose

- 1. This report asks you to:
 - **sign** the draft notice for the *New Zealand Gazette* (Appendix A) to establish the new council constitution for the Manukau Institute of Technology (MIT); *and*
 - **sign** a letter to the council Chair of MIT confirming that you have done so.

Background

- 2. Under recent amendments to the Education Act 1989 (the Act), if the council of an institution of technology or polytechnic (ITP) provides you with a new constitution, you establish the constitution by publishing a notice in the *New Zealand Gazette*.
- 3. As Minister, you do not have discretion to decline the new constitution provided that it complies with the legislation and is submitted to you by 24 August 2019.
- 4. ITP constitutions have just three essential elements: name of the council, date the constitution comes into effect (which is 24 October 2019), and number of council members. No restriction exists on including additional information.

The new constitutions increase council size to allow for staff and student members

- 5. Amendments to the Act in 2018 (sections 222AA(1) and 222AD(4)) require the council to have between 8 and 10 members and to ensure that—
 - at least one member of the council is a permanent member of the teaching or general staff elected by the teaching and general staff to represent them; OR one member is an elected member of the permanent teaching staff and one member an elected member of the permanent general staff; and
 - at least one member is a student who is enrolled in the institution and elected by the students of the institution to represent them.
- 6. The TEC confirms that the draft constitution for MIT is fully compliant with the legislation.

We need your authority to publish a new constitution

7. The new constitution will be established by your publishing a notice in the *New Zealand Gazette*. We recommend that you publish the notice as soon as practicable.

Notice Text: Pursuant to clause 18 of Schedule 1 of the Education Act 1989 ("the Act"), the Minister of

Education gives the following notice.

Notice

- This notice may be cited as the Constitution of the Manukau Institute of Technology Council Notice 2019.
- 2. This notice comes into force on 24 October 2019.
- From 24 October 2019, the Council of the Manukau Institute of Technology comprises ten members.
- 4. The Manukau Institute of Technology Council shall be constituted as follows:
 - a. Four members appointed by the relevant Minister
 - b. Six members appointed by the Council, of whom
 - i. at least one member appointed by the Council will be a permanent member of the general or teaching staff who has been elected by the permanent general and teaching staff to represent them, <u>and</u>
 - ii. one member will be an enrolled student who has been elected by the student body to represent them.
- 5. Appointments will be made in accordance with the Education Act 1989 and the Manukau Institute of Technology Council statutes.
- 6. In accordance with the Education Act 1989, the decisions of the Manukau Institute of Technology Council shall not be invalidated by any vacancy in the membership.
