Introduction

What are delivery classifications?

Delivery Classifications

To receive funding from the Tertiary Education Commission (TEC) tertiary education organisations (TEOs) must assign a classification to each micro-credential, course or programme provided that is funded through:

- » Delivery at Levels 1 and 2 on the NZQCF (NZ Qualifications and Credentials Framework) (DQ1-2)
- » Delivery at Levels 3–7 (non-degree) on the NZQCF and all Industry Training Fund (DQ3-7)
- » Delivery at Levels 7 (degree) and above on the NZQCF (DQ7+)
- » Youth Guarantee (YG).

Micro-credentials, courses and programmes need to be assigned their correct classifications so they can be funded correctly. Delivery classification and funding rate data is also used for reporting and monitoring, so it's important to follow this guide.

The classifications are essential when you:

- » use Services for Tertiary Education Organisations (STEO)
- » submit through the Single Data Return (SDR)
- » submit data to the Industry Training Register (ITR).

This guide will help you assign the right classification for the micro-credentials, courses and programmes you provide. It lists all the available classifications, and important things for you to note about them.

Legal requirements for TEOs and the TEC

Tertiary education is funded under the legal framework of the Education and Training Act 2020 (the Act) and any funding mechanisms issued through section 419 of the Act. Funding mechanisms require TEOs to accurately assign each of their micro-credentials, courses and programmes to the relevant delivery classifications and associated funding categories.

You must also choose a name for your provision that accurately describes most of its content. This helps us make sure that each component part or course is classified correctly during our approval process.

We validate the classifications and funding categories you have assigned. If we think the classification for a course or programme may be incorrect, we will contact you to clarify and amend if needed.

How do the classifications work?

Each classification is based on subject matter and is identified by a numeric code with a hash (eg, #17). Under each delivery classification in this guide is a table with two parts: **Funding category** and **UFS subject category**.

Funding category:

The funding category code is made up of two parts, an alphabetic code and a numeric code.

Alphabetic codes (eg, B) identify the different funding categories assigned to each delivery classification as prescribed in the DQ7+ funding mechanism.

Numeric codes (eg, 1 – 4) are based on the level and intensity of the study as prescribed in the DQ7+ funding mechanism.

UFS subject category:

The UFS subject category is for delivery funded through DQ3-7. An 'F' code (eg, F2) indicates the published subject category that this classification is assigned to for delivery on the Unified Funding System (UFS). This is paired with the mode of delivery to determine the funding rate for DQ3-7 delivery.

Example:

#17: Health-Related Professions

Provision	Funding category	UFS subject category that TEC will assign
Degree and higher-level study	B1 – 4	Not applicable
Diploma	B1	F2

'Delivery classification #17: Health-Related Professions' has funding category code B1 for DQ3-7 delivery, and we assign it to DQ3-7 subject category F2.

For DQ7+ provision of this classification, the funding category code may range from B1 through to B4, depending on the level and research intensity of the micro-credential, course or programme. The funding rate is determined based on the assignment of the correct numeric code to the funding category.

How to choose the right funding category code for your provision

To assign the correct funding category for your provision, you must consider its qualification level and research intensity, then add a numeric code to the given alphabetic code. This allows the funding rate to be determined.

The table below explains the numeric code categories and how to assign them.

Some classifications have a set numeric code. In this case, please only assign the numeric code listed. For example, classification #38: Foreign-Going Nautical has a set funding category of S1.

Numeric codes (classification by level and content of study)

- | | |
|----------|---|
| 1 | Courses designed for non-degree programmes or credentials with no research requirement, including certificates and diplomas. |
| 2 | Courses designed for undergraduate degree programmes or credentials, including Bachelor's degrees, graduate certificates and diplomas. |
| 3 | Courses designed for taught postgraduate programmes, including postgraduate certificates and diplomas, Bachelor's degrees with Honours, and taught Master's papers. |
| 4 | Research-based postgraduate programmes, including Master's theses and dissertations of 1.0 Equivalent Full Time Student (EFTS) or more for Master's and Doctoral study. |

Example: An undergraduate medicine course is numeric code 2. A postgraduate medicine course is numeric code 3 (if a taught course) or 4 (if research based).

Important notes on numeric code 3 – for taught postgraduate delivery

The essential principle of postgraduate education is that the learning involved is at Level 8 or higher on the NZQCF. A certificate or diploma can be classified as a postgraduate qualification if:

- » it follows on from an undergraduate degree of the same discipline and is at Level 8 or higher on the NZQCF, or
- » it is equivalent to the first year (Diploma) or half year (Certificate) of a Master's degree.

Numeric code 3 must not be applied to an Honours degree awarded as a result of the learner's superior achievement in an undergraduate course. A course or qualification cannot be classified as a postgraduate programme if:

- » it is the fourth year of a four-year undergraduate degree, or
- » it is a graduate certificate or diploma that equates to the final year of an undergraduate degree and is open to graduate learners from other undergraduate programmes.

An Honours course can be categorised as a postgraduate course if:

- » entry to the Honours programme requires a learner to have completed a Bachelor's degree, or
- » a learner is specifically admitted into a final-year programme, or
- » a course is specific to an Honours stream.

Important notes on numeric code 4 – for research-based postgraduate delivery

'Research-based' postgraduate qualifications are eligible for numeric code 4 funding rates.

For the purposes of the DQ7+ Fund, a qualification is 'research based' if the research component comprises at least 1.0 EFTS. Note that this definition is different to the Research Degree Completions component under the **Performance-Based Research Fund (PBRF)**, which includes qualifications with research components totalling 0.75 EFTS or more.

You may allocate numeric code 4 for research-based postgraduate qualifications, including a Master's thesis/dissertation, of 1.0 EFTS or more, for Master's and Doctoral study.

To allocate numeric code 4 for a research-based postgraduate qualification, the qualification must meet **all these criteria**:

- » It has an EFTS value of at least 1.0 EFTS. (This total value may be spread over more than one year.)
- » It includes one or more courses at Level 8 or higher on the NZQCF that total a minimum of 1.0 EFTS.
- » It requires a learner, who is supervised, to produce a substantial research output that amounts to 100 percent of the learning and assessment for that qualification.

Note: A course that is preparatory to a thesis, such as research methods, is not a postgraduate course.

When to use the Delivery Classification Guide

You must use the correct delivery classifications for these submissions and reports:

Submission through Services for Tertiary Education Organisations (STEO)

TEOs submit information through the STEO application to seek approval for TEC funding for a micro-credential or programme leading to a qualification.

When you submit this information, you must use the Delivery Classification Guide to select the appropriate classification and funding category for the courses or components of any programme or micro-credential.

Courses reported through the Single Data Return (SDR)

For courses reported to the TEC through the SDR, TEC funds individual courses, not full programmes or micro-credentials.

Once a programme or micro-credential has been approved by the appropriate external quality assurance body, and TEC has agreed to fund it, you must disaggregate it into component parts or courses and assign them each their own classification.

Programmes reported through the Industry Training Register (ITR)

The disaggregation requirement for the SDR does not apply to programmes reported to the TEC via the ITR in 2024.

For DQ3-7 delivery in these programmes (delivered under the Work-based, Work-based Pathway to Work, and Assessment and Verification modes of delivery), a single classification and funding rate can be assigned to each programme. Delivery of provider-based aspects of these programmes is subject to the same classification requirements as those of courses reported through the SDR.

How to use the Delivery Classification Guide

Select the classification and associated funding category that best fits your micro-credential, course or programme. Important points to remember:

- » **At least 90 percent of delivery content must fit into the classification assigned to a course**, unless the **programme basis rule** applies.
- » The classification is determined by content of the course, not the course name. For example, a course may be called 'Environmental Science' but could be classification #01, #03 or #18 depending on the content.
- » In some disciplines, you need to consider the level of the course when choosing the appropriate classification for component parts or courses. Some courses are funded at different rates or under different codes, depending on the year of study. For example, Years 2 and 3 of an undergraduate medical degree are classified as #15, while Years 4 to 6 are classified as #37.
- » Read the notes below each classification. These tell you more about the types of courses that fall under the classification and add extra guidance.

Classifications of programmes and qualifications for DQ1-2 delivery

In the SDR, component parts and/or courses within programmes at Level 2 on the NZQCF can have a 'maximum' funding rate of F2 (delivery component funding rate category). For example, engineering trades at Level 2 on the NZQCF must be classified as #22. In the ITR, this applies to each programme.

The programme basis rule

What is the programme basis rule?

In some cases, the TEC has approved a ‘programme classification’. This allows a single classification code to be assigned to all the components that are specifically relevant to the subject matter of a programme of study. A programme classification means all specified components are funded at the applicable funding rate for that classification.

A programme classification has been approved for specific programmes of study with these classifications:

- » #02: Architecture; Quantity Surveying
- » #07: Dentistry
- » #11: Engineering; Technology
- » #11.1: Priority Engineering
- » #11.2: Pilot training (Diplomas only)
- » #13: Health Sciences
- » #15: Medicine
- » #17: Health Related-Professions
- » #23: Veterinary Science
- » #23.3: Veterinary Science Undergraduate
- » #24–37: Clinical Training Classifications
- » #38: Foreign-Going Nautical

There is more information about how the programme basis rule applies to those classifications under their individual entries.

Exceptions to the programme basis rule

The programme basis rule **cannot** be used for these types of courses:

- » **Elective, non-specialist courses:** Some programmes and qualifications combine specialist courses with elective courses in other subject areas. These courses do not fall under the programme basis rule, as the rule applies to the core subject matter of the programme of study. TEOs must still assign the appropriate classification to non-specialist, elective courses undertaken by a learner (eg, an elective language paper within an architecture degree.)
- » **Postgraduate programmes:** Postgraduate programmes cannot use the programme basis rule. Disaggregate courses and give them each the appropriate delivery classification, based on course content.

The programme basis rule applies based on the programme the learner is completing, not individual courses. For example, an elective engineering paper as part of an arts degree could be classified as #11: Engineering, but the learner is not enrolled in an engineering programme, so the programme basis rule does not apply.

Changes to this guide for 2024

TEC reviewed the Delivery Classification Guide in 2023. It has been updated to stay current, incorporate changes announced through Budget 2023, and include more specific guidance.

Significant changes for 2024 are:

- » the removal of classifications #40 Te Reo Māori and #41 Tikanga Māori
- » the introduction of new classification #42 Mātauranga and Te Reo Māori to implement the Budget 2023 increase of funding for courses that promote the learning of mātauranga Māori.

Delivery Classifications

This section of the guide includes detail on delivery classifications #01–#42.

Most delivery classifications give the funding category, types of courses that fit within the classification, and course exclusions. Course exclusions indicate provision that is not to be funded within the classification.

#01: Agriculture; Horticulture

To use this classification, **at least 90 percent** of course content or subject matter must be related to agriculture and/or horticulture. DQ3-7 programmes must only use funding category H2 if they are at level 5 or above on the NZQCF and targeted at primary industry management. Otherwise they must use funding category L1.

Diploma/Certificate (excluding specialised agriculture and horticulture)	L1	F3
Diploma/Certificate in specialised Agriculture and Horticulture	H2	F5

- » Animal Science, Plant Science, and Soil Science courses. These must be classified as #18.

#02: Architecture; Quantity Surveying

Using the programme basis rule

This classification can be applied according to the **programme basis rule** for professional courses specific to the discipline. Elective courses of general interest that are not specific to the discipline must be separated and assigned their appropriate classifications.

- » Quantity Surveying

A provider of osteopathy courses must be accredited by the Osteopathic Council of New Zealand, pursuant to section 12 of the Health Practitioners' Competence Assurance Act 2003 (HPCA) before its programmes can be approved for funding under this classification.

You may use this classification for the following courses if they are focused on programming elements rather than other discipline areas. These courses require knowledge of programming languages/protocols including evidence of scripting, authoring, and/or dialogue with operating systems:

- » Computer Integrated Manufacturing (CIM)
- » Computer Numeric Control (CNC)

You may use this classification for the following courses if they involve the learner developing advanced knowledge of technical construction or performance of IT equipment and systems:

Definitions

In the Delivery Classification Guide, unless the context otherwise requires:

90 Percent Rule means at least 90 percent of the content or subject matter of an individual course must fit into a single classification of the 1–42 classification prescriptions for it to be assigned that classification.

Capped Enrolments mean enrolments in certain qualifications where the Government has placed a limit or cap on the number of Equivalent Full Time Students (EFTS), for example, certain universities have capped places in medicine programmes.

Course means a basic, assessable unit of education and/or training. A course or collection of courses forms a programme of study, which if completed successfully, results in the award of a qualification.

Course Equivalent Full-Time Student (EFTS) Factor means the portion of the total EFTS value for the qualification that a course represents. Individual course factors are calculated by the TEO and must be endorsed by the TEC.

Delivery Classification (Classification) means a numeric code and title as provided in Appendix 1 of the Delivery of the New Zealand Qualifications and Credentials Framework at Levels 7 (degree) and above (DQ7+) Fund Funding Mechanism that is used by the TEC/MoE for statistical and funding purposes.

Disaggregation means the process by which a qualification and its EFTS value is split into courses and course factors, which are then allocated delivery classifications and funding categories to determine funding.

Elective(s) means optional courses within a qualification from which a learner makes an individual choice to meet the requirements of the qualification.

Funding Category means a grouping of course classifications into bands for the purpose of funding courses/programmes. A funding rate applies to each funding category. The funding category includes:

- (a) an alphabetic code that relates to the course classification (based on subject)
- (b) a numeric code that reflects the level of study (ie, non-degree, undergraduate, postgraduate).

Funding Conditions or **Funding Conditions Catalogue** means the annual updated version of the funding conditions for which TEOs who receive funding must follow. See the Funding Conditions Catalogue.

Funding Confirmation Letter (FCL) means the letter we send you that outlines: the funding we will give you on which conditions are imposed; TEO-specific conditions imposed on your funding; and any minimum requirements.

Industry Training Register (ITR) is the online data collection service that captures information about activity in the industry training sector in near real time.

NZQA means the New Zealand Qualifications Authority.

NZQCF means the New Zealand Qualifications and Credentials Framework.

Postgraduate Study means study beyond the final year of a Bachelor's degree (Level 8, 9, or 10) undertaken by an enrolled learner in a quality assured programme of study at a recognised TEO.

Programme Basis Rule means that a classification applies to a complete programme or qualification. While programmes are still disaggregated into courses of study with individual course factors, the courses are all claimed in one classification.

Qualification means the official award given in recognition of the successful completion of a programme of study.

Single Data Return (SDR) means the set of data items that are specifically required by the Ministry of Education and TEC for funding, monitoring performance, publishing performance information, as well as statistical reporting purposes.

Tertiary Education Organisation (TEO) means a Tertiary Education Organisation as defined in section 10 of the Education and Training Act 2020.

University means a University as defined in section 10 of the Education and Training Act 2020.
