



About the Private Training Establishment sector Government expectations of the Private Training Establishment sector

In 2011, the TEC funded 200 individual Private Training Establishments (PTEs) through its Student Achievement Component fund, for fewer than 20 to over 1,500 equivalent full-time student places.

Comparing PTEs may be difficult due to additional funding for some PTEs, and also the different sizes of PTEs.

The nature of enrolments at a specific PTE will influence its performance as well as the quality of the provision. For example, part-time and extra-mural students often have work or family commitments and cannot devote as much time and energy to their studies. They may also have different study goals.

An increase in enrolments in lengthy qualifications in 2011 may lower some TEOs' gualification completion rate.

The government expects PTEs to:

- Enable students to complete high-quality qualifications that lead to employment or higher-level education
- Deliver tailored learning opportunities, such as marae and iwi-based provision and Pasifika learning enviornments and training
- Provide speicalised qualifications and training

Tertiary Education Strategy

The Tertiary Education Strategy calls for better performance from the tertiary education sector as well as raising achievment for all learners under 25, and for Māori and Pacific learners.
