Thank you for your request, received on 10 May 2019, for the following information under the Official Information Act 1982 (the Act):

"Under the provisions of the Official Information Act (1982), I would like to request from TEC the number of the following qualifications that have been awarded each year from 2010 to 2019 inclusive - <u>National Certificate in Security</u> Level 2, 3, 4, 5 and 6. I understand that the Level 6 qualification is now a diploma? If that is the case then please include in the OIA request the number of level 6 qualifications awarded before and after this was transformed into a diploma."

I am releasing the information requested in the attached tables. Please note:

- The number of learners are those eligible for Tertiary Education Commission funding.
- This data has been compiled specifically to respond to this question. It uses administrative data collected by the Tertiary Education Commission for the purposes of funding tertiary education. Care should be taken when making comparisons with other data collected or compiled for other purposes
- Data has been rounded to the nearest 5 to protect the privacy of individuals, so the sum of individual counts may not add to the total.
- There is no completed qualification recorded above Level 3 in National Certificate in Security for TEOs and above Level 4 for industry training organisations (ITOs).
- Prior to 2011, ITO data was sourced via a different data reporting system. As these two systems are fundamentally different we are unable to provide comparable data for the 2010 calendar year.
- As the 2018 calendar year data is yet to be finalised we are unable to provide this to you at this time. Your request for 2018/2019 data is refused under section 18(e) of the Act.

I am satisfied, in terms of section 9(1) of the Act, that the need to withhold the information referred to above is not outweighed by other considerations that render it desirable, in the public interest, to make the information available.
