Thank you for your request, received on 14 January 2020, on performance-linked funding (PLF) under the Official Information Act 1982 (the Act).

I am releasing the information requested for PLF referenced in the attached excel sheet Appendix 1. This table provides you with the total Student Achievement Component (SAC), the PLF repayment amounts, PLF percentage of total SAC funding, 5% of total SAC funding amount and PLF percentage of 5% SAC funding broken down by calendar year for each provider.

I have interpreted your request for the upper and lower benchmarks levels set and published by the TEC each year to be for the upper and lower threshold. You can access the information that TEC has published for each year via the National Library of New Zealand for Tertiary Education Commission [electronic resource]-Te Amorangi Mātauranga Matua; here is a link to the TEC archived website https://natlib.govt.nz/records/20712811. However, for your convenience we have attached the links to the threshold information published by year in Appendix 2.

The formulae used for the PLF during operation can also be accessed via the links supplied in Appendix 2. However, the formulae for the 2017 and 2018 years were published on their own individual page which can be accessed in Appendix 3. Please note that from 2018 PLF for part-time and full-time study was calculated separately so that like for like provision can be better compared. This replaced the previous part-time adjustor; more information on the methodology can be found here:
